## 1. Overview

This paper provides an update on the Solent Economic Recovery Plan (version 2), the new economic strategy for the Solent LEP area (Solent 2050), and the development of a Ten Point Plan for a Green Industrial Revolution in the Solent.

## 2. Recommendations

Board Members are asked to:

- Note the update on the Solent Economic Recovery Plan (Version 2);
- Consider the final draft of Solent 2050 (attached in Annex A) and Agree to delegate authority to the Executive and Chair to finalise the strategy for publication;
- Note the update on the development a Ten Point Plan for a Green Industrial Revolution in the Solent and provide Advice on the approach to the work.

## 3. Economic Recovery Plan (Version 2)

The Board considered the updated Solent Economic Recovery Plan at its meeting on 26<sup>th</sup> February 2021 and agreed to delegate authority to the Executive to publish. The ERP was published following the local authority elections in May 2021 and the updated Economic Recovery Plan can be [found here](#).

## 4. Solent 2050

The Board last considered the draft Solent 2050 strategy at its strategy session in December 2020, where the consultants supporting the LEP with the work provided an update and sought the advice of the Board on the implications of the pandemic on the future Solent economy.

Since that time, the area was moved into tier 4 coronavirus restrictions on 19<sup>th</sup> December and a further national lockdown started from 6<sup>th</sup> January, deepening the economic impact of, and reinforcing trends already accelerated by, the pandemic.

To better understand the impacts of the pandemic on the future Solent economy, the LEP has held a series of sessions with stakeholders. These have included:

- Solent Coronavirus Business Support Task Force - 10<sup>th</sup> March 2021
- Solent LEP AGM - 12<sup>th</sup> March 2021
- Solent LEP Executive Team Meeting - 15<sup>th</sup> March 2021
- Thought Leadership Workshop - 27<sup>th</sup> April 2021

Across these sessions we have engaged with over 160 people and secured valuable and varied insight into the impacts and consequences of the pandemic on the future of the Solent economy.

More recently with the progress through the roadmap and the opening up of the economy there is now a shift in focus moving from economic impact (as set out in the ERP) to economic recovery and

the Plan for Growth. Therefore Solent 2050 should be a strategy that establishes a platform and baseline for future growth, drawing on any experiences in the past 18 months but with a firm focus on unlocking economic opportunities moving forward.

The consultants will attend the Board meeting and provide an update on the work they have undertaken to finalise Solent 2050, with the draft final document provided as Annex A. In preparation for the session the board may wish to consider the questions set out in the briefing paper attached in Annex B.

The Board are asked to:

- **Consider** the final draft of Solent 2050 and **agree** to delegate authority to the Executive and Chair to finalise the strategy for publication.

## **5. Ten Point Plan for a pathway to Net Zero for the Solent economy**

Following on from the update above on Solent 2050, the Board will be aware that one of the strategic priorities of Solent 2050 is "*Pioneering approaches to climate change adaptation and decarbonisation and establishing real expertise which other regions – nationally and globally – can learn from.*"

In addition, the Government published the [Ten Point Plan for a Green Industrial Revolution](#) in November 2020, which sets out the approach government will take to support green jobs, and accelerate the path to net zero. Local Authorities in the Solent and our major economic assets have also set ambitious targets to achieve Net Zero and this ambition is an underpinning strand of the recent Freeport success.

Consultants will attend the session to present to the Board a proposal for developing a high level Ten Point Plan for a Green Industrial Revolution in the Solent. This follows on from the presentation at the December Board Strategy session on driving a green recovery and laying the foundations for sustainable growth. The Board is asked note the update on the development a Ten Point Plan for a Green Industrial Revolution in the Solent and provide advice on the approach to the work.
